CONSTRUCTION UPDATE: Chambers Flat Road Upgrade

June – July 2023

SEE Civil is the appointed contractor to construct the Chambers Flat Road upgrade between Mount Lindesay Highway to just north of Kings Way.

Current works

ZONE 1 & 2

At the beginning of June, the eastbound lane closure was extended to include Zone 1 & 2.

The current works for these zones include:

- Ongoing earthworks
- Removal of existing drainage
- Road reserve works
- Driveway drainage works
- Delivery and removal of equipment, plant, and materials
- Laying the permanent pavements of Chambers Flat Road.

ZONE 3

Work to build the new Norris Creek bridge abutments is now complete and is in its 'settlement' period.

Once the settlement is achieved, work will begin to build the new Norris Creek bridge structure.

Settlement is expected to take approximately four months, *subject to construction and site conditions including permits and approvals.*

Property access during works

Property crossover works will temporarily affect properties adjacent to Chambers Flat Road.

To minimise impacts on households, SEE Civil will contact property owners ahead of work to discuss activities and property access.

ZONE 4

Relocation of bus stop at Kings Way

From Monday 26 June, the bus stop located on Chambers Flat Road at Kings Way will be relocated east toward Grassway Court to allow works to progress in the corridor. The Chambers Flat Road bus stop at Kings Way is scheduled to be reinstated in late 2024.

ZONE 4

Traffic changes

From late June 2023, Chambers Flat Road, from Kings Way to Riverina Road will be reduced to one *contraflow* lane to allow permanent pavement works to be built.

Traffic will be able to travel in both directions under the control of traffic lights. This work is expected to take approximately **six to eight weeks**, *subject to weather and construction conditions*.

Once complete, traffic will be switched from the existing Chambers Flat Road alignment to the new alignment.

Please note that this temporary arrangement does not apply to the one-way traffic system in place from Kings Way to the Mount Lindesay Highway and will remain until late-2024.

Watermain relocation works

The water main located on the northern side (oddnumbered properties) of Chambers Flat Road between **Kings Way and 1541 Chambers Flat Road** needs to be lowered. SEE Civil will excavate a trench along the road reserve and across property driveways to prepare for the new water main to be installed. Property access will be maintained during this work by using a steel plate over driveway excavation areas.

Watermain shutdown

Logan Water will complete an **eight-hour water shutdown** to connect the new water main to the network on. Affected properties will receive written confirmation in their letterbox 48 hours before the shutdown.

Tips to prepare for the water shutdown:

- Ensure all faucets are turned off. This will ensure when reconnection occurs, water is not released without you knowing.
- Turn off your property water pump (if you have one) so that it is not damaged from running dry.
- Fill your kettle and fill water jugs
- Disconnect appliances that use water
- Once reconnected, run your water for approximately 10-15 minutes to flush the pipes.



What to expect

During construction, you may experience:

- reduced speed limits and traffic changes. For the safety of motorists and workers, temporary traffic changes will occur throughout construction including intermittent traffic controls such as assisted entry and exit to private properties, traffic light controls, and direction of traffic control to allow safe movements of plant, heavy vehicles, and equipment in Chambers Flat Road between Kings Way and Riverina Road
- frequent lane adjustments and changed road alignments
- noise, dust, and vibration
- changes to how your waste bin is collected
- temporary changes to property access
- odour during asphalting and sealing works
- increased truck movements
- service interruptions to water.
- weather and site conditions may impact works and scheduled start and finish times

Drone survey technology

Drone flights will occur intermittently throughout the project to capture and monitor progress and assist engineering. The next scheduled flight will occur between **Monday 26 June and Saturday 1 July 2023.**
