- nuisance
- significant disturbance, inconvenience or annoyance to a person's enjoyment of their place of residence

Please Note:

In seeking this approval, Council must determine if the applicant is a suitable person as stated in *Local Law No. 4 (Animal Management) 2002 – S26*

Council may deem an applicant not a suitable person if;

- the person has committed more than 2 offences under *Local Law No. 4 (Animal Management) 2002* within the preceding 3 year period irrespective of whether the person has been prosecuted for these offences;
- the nature of any offence committed by that person is under this local law or an animal law;
- the person has been the keeper of an animal whose approval has been cancelled under an animal law;
- the person has committed an offence involving cruelty to an animal;
- any unsatisfactory past conduct on the part of that person in relation to the keeping of an animal;
- the person complies with the prescribed criteria relating to the keeping of animals;
