- 1. The application form including the signed statement (fees are currently waived).
- 2. Details of the road excavation works including the design, dimensions, construction technique and a site sketch/drawing and specifications of the works to be undertaken. The sketch/drawing should include the front boundary of properties, driveways, kerb and channelling, the footpath and public utilities (i.e. power poles, Telstra pits, etc). It should show the measurements (in mms) between these items.
- 3. Details of the contractor who will be undertaking the road excavation works and a copy of their public liability insurance of not less than ten million dollars (\$10,000,000) will be required.
- 4. Evidence that you have contacted and received "Dial Before You Dig" service information (provide copies of current service plans).
