



The 7 Get in the Game projects for the 2017/2018 financial year are all under construction and early planning has commenced for the 7 Get in the Game projects for the 2018/2019 year.

# Quarter 3 Summary

During Quarter 3, First Five Forever submitted its 2017 calendar year report to the State Library of Queensland. A 19% increase in the number of First Five Forever activities and a 29% increase in the total number of participants when compared to 2016 figures was reported. Several of Logan's First Five Forever projects featured in the QUT Digital Media Research Centre's report: Evaluating the Impact of the First 5 Forever Initiative. The report commended the initiative as a community facilitator and connector, supporting families and children through a culture of participation and lifelong learning. Over Quarter 3, First Five Forever continued to work with a number of community early years learning facilitators to develop strategies and programs for supporting the development of literacy skills for children under five and their families. This includes ongoing delivery of activities in the Yarrabilba, Mundoolun and Logan Village communities and with Kingston, Woodridge and Yugumbir State Schools.



# Interpretation & Response:

In the third quarter the 2018 school program commenced with the immunisation team sending out approximately 7,500 consent forms to the School Coordinators of the 31 schools in Logan City Council. Of the 7,442 students 5,390 forms were returned for processing giving a return rate of 72% for both year seven and ten. This year's program will be delivered in two visits. The first visit has commenced in this quarter with year seven students receiving one of two doses of Human Papilloma Virus and one dose Diphtheria, Tetanus, Pertussis and the year ten students for the one dose of Meningococcal ACWY. Currently 20 of the 31 schools in Logan City Council have been visited giving 65% of schools in the first visit completed. The remainder is to be done in April 2018.

### Interpretation & Response:

Actions were achieved for the Arts, Culture and Heritage strategy 2014-2017 under key strategic outcomes of development, engagement, places and spaces, partnerships and communication during the third quarter of the 2017/2018 financial year.

Highlights during this period include:

- 11 exhibitions at Logan Art Gallery, 69 public programs and outreach events, two Logan Artworkers Networking Events and three Music in the Gallery.
- Local artist Esther Austin launched her book Looking at art from within, coinciding with her exhibition at Logan Art Gallery and her imminent 90th birthday.
- Community consultation was undertaken on the draft Creative city: Logan City Council Arts, Culture and Heritage strategy 2018-2022.
- Concept design presentations were held for two public art projects funded through the Divisional Infrastructue Capital Improvement Program (DICIP):
   Wineglass Drive and Chester Park water tower.
- Public art and heritage trail Browns Plains Berrinba to Meadowbrook is being designed in readiness for Divisional Councillor feedback.

Multiple meetings were attended to identify opportunities for Logan City Council to support the rollout of the NDIS including internal meetings and external meetings with Redland City Council, City of Ipswich, local networks including the Logan Disability Coalition and the National Disability Insurance Agency (NDIA).

Staff attended the Logan Dementia Friendly Community Steering Committee meeting to discuss and agree upon activities for 2018 and next steps for developing an action plan.

Staff met with HELP Enterprises to discuss ideas and opportunities for employment pathways for people living with disability in the city.

A presentation was arranged for the National Disability Insurance Scheme (NDIS) at the February 2018 City Lifestyle and Customer Service Committee, where a senior representative from the NDIS provided an overview of the roll out in Logan, and answered questions from Elected Members about the impact of the NDIS on the Logan community.

### Interpretation & Response:

During the third quarter, the main focus of road safety activities were planning and support for Police campaigns and Commonwealth Games traffic impacts. Traffic data and some mapping for interception points assisted Police during the Christmas and Easter school holiday road safety campaigns. Council took the lead in arranging traffic management for the Queens Baton Relay event on 1 April 2018 through Daisy Hill and Beenleigh.

The Road Safety Working Group met on 31 January 2018 and weekly traffic meetings continued with Queensland Police and Department of Transport and Main Roads road safety officers. Other road safety actions included: updating road safety marketing action plan; promotion of Patrick Pace Car and deployment to school zones during school term; planning for Fatality Free Friday (May 2018) and Road Safety Week (August 2018); and commencement of fortnightly road safety facebook posts.

### Interpretation & Response:

The Community Safety Program continue to successfully deliver the initiatives of the City of Logan Safe City Strategy and Action Plan 2016-2020. For the quarter of January - March 2018, the following significant achievements have been made against the five key areas of interest of the strategy and action plan:

#### Strategic approach

The 2018 Safe City Logan Symposium was held with the focus on the illegal drug, Crystal Methamphetamine (ICE). Registrations opened on 16 March 2018.

# Community confidence

The Safe City Logan perceptions video project has now been completed with the three videos reaching a combined audience of over 79,000 people on Council's Facebook page. In conjunction with the Queensland Police Service, personal safety talks were delivered to seven different primary schools across divisions 1, 8 and 10. This initiative engaged with approximately 600 students between the ages 5 to 9 years.

# Places and spaces

During the January - March 2018 period, 10 Crime Prevention Through Environmental Design audits were completed across the City of Logan in response to Council initiated or customer requests. A total of 20 mobile safety camera deployments were successfully undertaken throughout the January - March 2018 period.

# **Partnerships**

During the January - March 2018 period, significant collaborative work has occurred with the Queensland Police Service, including on a joint anti-robbery initiative with the Logan District Criminal Investigation Branch. This campaign focuses on reducing robbery offences in the Logan District. The key message underlying this campaign is 'Phone Down, Eyes Up' with the focus on the individuals who are being targeted in these robbery offences.

### Communication

Throughout the January - March 2018 period, the Community Safety Program have committed to continuing to promote a safe and liveable community by keeping City of Logan residents informed of strategies that promote community safety and raise awareness of crime prevention.


#### Interpretation & Response:

In the previous quarter it was reported the scheduled public release in August 2018 for 'Way2Go Connecting Logan', the branded integrated local transport plan, would not be affected by the delay in transport network modelling.

During the third quarter, it was confirmed the delay in modelling has affected the completion of options analysis and evaluation critical to the drafting of 'Way2Go Connecting Logan'. The revised public release date is now late October 2018 subject to successful community and stakeholder engagement to be completed in July 2018.

Looking ahead to the next quarter the project team plans to complete the draft plan 'Way2Go Connecting Logan'. Following Council approval, the draft plan will undergo public consultation.

Considering the project will not achieve its original target date (June 2018), it is requested that the project be removed from the 2017/18 Operational Plan and carried into the next financial year (2018/19 Operational Plan) with a target date of October 2018 to allow adequate time for transport modelling and community engagement prior to Council adoption and release to the public.



Interpretation & Response:


Third Quarter Reporting Target: 82% Lowest Acceptable Level: 80%

Actual: 81%

The delivery of the road maintenance program is slightly below target for the third quarter due to a change in the calculation approach to the Restoration Provision for Bega Road resulting in additional operating revenue recognised.

Capital works expenditure is below expected targets as the Gravel Road and Shoulder Seal (GRASS) program for 2017/2018 experienced efficiencies in work practices. Additional projects have been negotiated and funding will be carried over to the 2018/2019 financial year.

During the third quarter, 96.63% of customer requests received were completed within target timeframe.



# Interpretation & Response:

Delivery of the Capital Road and Drainage Program is meeting expected expenditure at 105.1% at the end of the third quarter.

Notable projects delivered throughout the third quarter include:

- Pindari Street Catchment Master Drainage Project Stage 1 and 2 (\$4.55 million)
- City-wide Bus Stop Upgrades (total \$2.5 million)
- Dennis Road Catchment Master Drainage Project (\$1.1 million)
- Woodlands Drive Catchment Master Drainage Project Stage 12 (\$1 million)
- City-wide asphalt and spray seal resurfacing program (total \$18 million)

Contribution towards Johnson Road and Stayplton Road intersection upgrade project has also progressed (\$7.6 million).

Community consultation was completed allowing finalisation of project scope including the extent of on-road cycle lanes and off-road shared paths. The project scoping brief will be completed early in the next quarter to progress to detail design phase. It is anticipated that the project's schedule will be back on track in the next quarter for on-time delivery of its target date of June 2018.



Interpretation & Response:

The Logan Village Forum was held on 7 March 2018, with 122 people attending the morning session and 96 people attending the evening session. The Logan Village Forum website has been updated with videos of all the speakers, a video of key ideas from the community on the future of Logan Village as well as a fly-through 3D model of the future Logan Village centre.

All of the ideas that were submitted at the Logan Village Forum and subsequent community feedback sessions, focus group meetings and through the online ideas portal as well as several emails, letters and verbal feedback, are being collated, categorised and summarised and will be submitted to a future City Centres Special Committee as key outcomes from the Forum. The Logan Central Summit was successfully held on 11th May 2018, with 190 people in attendance.

#### Interpretation & Response:

The extra charges collected outside the PIA can be used to fund trunk conditioned by Council, whereas the extra charges collected inside the PIA can be used to fund strategic trunk not included in the LGIP (i.e. items that appeared in the Priority Infrastructure Plan (PIP) but were postponed to post 2026).


We are currently awaiting State Government (department of State Development, Manufacturing and Planning) assessment and decision on the grant application. The outcome will determine the future direction of this project.

Given the decision from State Government is expected to be delivered at the end of June 2018, the project will not be delivered in the 2017/18 financial year. It is therefore recommended that the project be removed from the 2017/18 Operational Plan and, pending successful grant outcome, included in the 2018/19 Operation Plan.




Interpretation & Response:


# ET1 - We enjoy jobs growth and economic prosperity with local and global reach



Interpretation & Response:

There was \$750,000 investment in automotive retail in the third quarter. Whilst the year to date target has not been reached, announcements in the fourth quarter are expected to meet the year end target.

Investment announced in April 2018 totals \$9 million, comprising \$7 million in capital expenditure for the construction of two buildings in Crestmead (5,000sqm in total), plus \$2 million in lease costs to occupy one of these (3,300 sqm) by a solar product and engineering consultancy.



Interpretation & Response:

During the third quarter 20 new jobs were created and 5 retained in the automotive retail sector. The year to date target has not been reached. The anticipated investment announcements in the fourth quarter will help bring the target towards the lowest acceptable level.

# Interpretation & Response:

In April 2018, Council made a written submission to the Senate Community Affairs Legislation Committee on the Social Services Legislation Amendment (Drug Testing Trial) Bill 2018.

The original purpose of the delegation in February was to advocate to the Federal Government prior to their budget deliberations on Council's infrastructure priorities and other matters. The Federal Government officially called for written submissions on budget matters and it was deemed appropriate to submit in writing rather than by delegation in this instance. The submission was adopted by Council at its meeting of 30 January 2018 Minute (No 7/2018).

Before the end of this financial year there will be one further delegation to Canberra in June for the Australian Local Government Association's General Assembly where four motions proposed by Logan City Council are scheduled for debate. This will mean that for this financial year the number of delegations will reduce from four to two. There have been a number of opportunities throughout the year to engage with the Federal Government through visits by Senators and Ministers to the City of Logan and through written submissions where appropriate.

It is therefore recommended that the delegations for this financial year be reduced from four delegations to two due to changing business needs that still allow for an appropriate level of engagement with the Federal Government in different forms.
