



Interpretation & Response:

On 29 November 2017, Phase 1, Community Infrastructure Plan Scoping and Initiation, was presented to the City Lifestyle & Customer Services Committee for information and was completed.

Phase 2, Desktop Research and Literature Review, has been completed. Phase 3, Community Infrastructure Audit and Needs Assessment, has commenced.



Interpretation & Response:

Expenditure variance is the result of the June invoices being slightly lower than expected.

The Logan Metro Sports Park project is fully operational, the 3 Get Playing Plus projects are all under construction with the Waller Park and Yarrabilba Sports Hub projects due for completion within the next 3 months.



Interpretation & Response:

 During the 2017/2018 financial year, the five strategic outcomes of the Arts, Culture and Heritage strategy were met, which include the following highlights:
Development: Libraries and Creative Industries continue to provide public programs responding to community interest. Ten Logan Artworkers Networking Events were held. Eleven applications for funding through the Regional Arts Development Fund committee were endorsed by Council. 21,455 people attended Logan Art Gallery, participated in events and activities or related outreach activities. Public programs were held in Local Studies for family history research.

- Engagement: Logan Art Gallery staff visited over 30 schools to select 150 artworks for the annual Artwaves exhibition of senior secondary school students. Ten Music in the Gallery events were held. Two Creative Markets and two family fun days were held which brought new audiences to the gallery. Art and Dementia tours were presented three times per month due to demand. Logan Live Music Month was launched on Make Music Day, 21 June. Creative Industries staff undertook community engagement and consultation to develop Creative city: Logan City Council Arts, Culture and Heritage Strategy 2018-2022 which was endorsed by Council.
- Places and spaces: ImagiNation Children's Festival Family Fun Day launch event held in September 2017 showcased Mayes Cottage House Museum. World War II heritage of Yarrabilba was celebrated through the 75 year anniversary of Camp Cable with an all-day event. Public art and heritage trails Logan Central to Kingston and Underwood to Eagleby were launched as both hard copy brochures and interactive, online trails. Public artwork was installed at Waller Park in Browns Plains.
- Partnerships: Partnership between State Library of Queensland and Logan City Council to support Logan City Council Libraries, and Regional Arts Development Fund partnership between Logan City Council and Arts Queensland both continue to deliver arts, culture and heritage to Logan's community. A QANZAC 100 grant supported original research into the heritage of Logan Anzacs, and the completed project was launched on Remembrance Day 2017, as part of Logan RSL's commemorative event.
- Communication: Libraries and Creative Industries staff worked with Marketing and Media teams to promote arts, culture and heritage through social media, newspapers and online. What's on quarterly brochure is promoted to 20,000 people. Consistent editorial in our Logan magazine sees Libraries and Creative Industries programs, events and activities delivered to every household. The 2018 Logan Art Gallery Exhibition Program was completed and the 2019 exhibition program is in draft form for presentation to Council.

Council's first Reconciliation Action Plan included 70 deliverables under 39 action items. During the 2017/2018 financial year, 93% of the actions were completed.

An Acknowledgement of Country has been printed on canvas and is on display at all nine Council libraries.

Council supported the City of Logan 2017 NAIDOC Flag Raising Ceremony.

Throughout 2017 over 450 Council staff attended the Banaam Aboriginal and Torres Strait Islander Cultural Intelligence Training (the tracking spreadsheet registered 300 attendees up to August 2017, however to date the number is more than 450).

Monthly Reconciliation learning circles held throughout the 2017 Year of Reconciliation included engaging with local Aboriginal and Torres Strait Islander young people on topics including stolen generation, closing the gap, art and culture, Indigenous planning and the Logan community.

The development of a second Reconciliation Action Plan has commenced to ensure Council continues to build on its commitment to reconciliation within the City of Logan.

Interpretation & Response:

During the fourth quarter and throughout the year, Council continued to work closely with external stakeholders to continue core delivery of road safety services consistent with SafeRoads4Logan Road Safety Action Plan 2017-2012.

Joint Traffic Agency Meetings between Council, Queensland Police and Department of Transport and Main Roads are held weekly to discuss road safety strategy and research, road incidents and other traffic operational planning issues. Workshops are held approximately once a quarter with road safety partners. The next workshop is scheduled for July 2018.

Coordination for key events has included Queensland Road Safety Week in August 2017 and Fatality Free Friday in May 2018 at Grand Plaza, which was well attended. Planning continues for delivery of motorcycle safety campaign and road safety week activities in July and August 2018 respectively. Other ongoing road safety partnership activities include mapping and surveillance support for Police tactical operations, senior driver education, targeted Learner Driver training, RYDA driver awareness sessions for school children and regular deployment of Patrick Pace Car at school zones.

The Community Safety Program continue to successfully deliver the initiatives of the City of Logan Safe City Strategy and Action Plan 2016-2020. For the 2017/2018 financial year the following significant achievements were made against the five key areas of interest of the strategy and action plan: Strategic approach

- During November 2017 a month-long crime prevention initiative within the priority development area of Flagstone commenced. This initiative focused on addressing emerging safety issues within the Flagstone community including home and property safety, child safety and drug prevention. The feedback received from the community regarding the activities that were undertaken was extremely positive and indicated that the target issues were successfully addressed.
- The 2018 Safe City Logan Symposium was held on 17 May 2018 and focused on the topic of Crystal Methamphetamine (ICE). A total of 139 people attended this free community event. Feedback from attendees was extremely positive, including that 100% either agreed or strongly agreed that they felt more educated on the topic of crystal methamphetamine after the event.

Community confidence

- Two Community Weeks of Action were delivered in July and September 2017, with over 60 crime prevention and community safety activities being coordinated throughout the city during these weeks.
- The Daniel Morcombe Foundation visited the City of Logan on 10 and 11 October 2017 to present personal safety talks to more than 2,600 primary school aged students across the city. The project increased awareness across the community of preventive measures that can be taken to reduce the likelihood of becoming a victim of crime in the City of Logan. This initiative received extremely positive feedback by all who were involved.
- The annual Safe City Logan community survey closed on 10 October 2017. Overall results from this survey were positive. The survey Key Findings Report was made publicly available in December 2017.
- The 2017 City of Logan Safe City Awards ceremony was held on 23 November 2017, with approximately 75 people in attendance. The awards ceremony acknowledged the work of many within the City of Logan who helped to make our city even safer.
- The Safe City Logan perceptions video project was delivered with the three videos reaching a combined audience of over 79,000 people on Council's Facebook page.
- Since January 2018, a total of 40 targeted community safety activities have been undertaken, engaging more than 4,000 residents. These activities have occurred all throughout the City of Logan and have included community safety information displays, Safe PL8 events and personal safety presentations.

Places and spaces

- A total of 53 Crime Prevention Through Environmental Design audits were completed across the City of Logan.
- A total of 78 mobile safety camera deployments (ute / van) were successfully undertaken.
- A total of 19 new permanent CCTV cameras were installed throughout the City of Logan.

Partnerships

- In partnership with Beenleigh Probation and Parole, the Community Safety Program has delivered the Building Social Capital Hubs project since June 2017. A total of 377 clients of Probation and Parole have been proactively involved and attended these hubs with an average of 58% being linked into a referral pathway for further support.
- The Community Safety Program worked closely with the QPS on the delivery of the Phone Down #EyesUp campaign. This initiative concluded in June 2018 with a 35.68% reduction in reported robbery offences throughout the Logan Police District during the campaign period. The initiative also reached more than 144,000 people through the social media campaign that accompanied the initiative.

Communication

The Community Safety Program have continued to promote a safe and liveable community by keeping City of Logan residents informed of strategies that promote community safety.

Interpretation & Response:

The 2017 Safe City Logan community survey closed on 10 October 2017, following a comprehensive marketing campaign on social media and at communitybased events undertaken during the six-week period that the survey was open.

Overall, results from the 2017 survey were positive, with a significant increase in the percentage of residents who feel safe living in the City of Logan (58.8% compared to 45.5% in 2016). Additionally, a significant increase was noted in the number of residents who reported feeling safe out and about or at home by themselves both during the day and of an evening, compared to the 2016 survey. Another notable increase was in the percentage of respondents who reported being satisfied with the level of community safety programs that Logan City Council delivers (69% up from 42% in 2016). The 2017 Safe City Logan community survey Key Findings Report was made publicly available on Council's website and promoted via a link on Council's

Facebook page during the week of 18 December 2017. A media release was also produced to promote the positive survey results.

The Community Safety Program has drawn on feedback from the 2017 survey as well as the Queensland Police Service (QPS) crime statistics, to create an action plan for the delivery of activities and events in 2018, which also targeted the top offences occurring in each Council division. Following development of the action plan a comprehensive project plan for the delivery against these survey results was developed.

This project was completed by May 2018.



The revised public release date is likely to be December 2018 and was endorsed by the project Steering Panel. This project is to be included in Council's Operational Plan 2018/19.

The delivery of the road maintenance program achieved budget for the 2017/2018 financial year.

The customer service performance bettered the 90% target.

Interpretation & Response:

Expenditure of \$70 million has been achieved against the Capital Road and Drainage Program for the 2017/18 financial year. Delivery was in line with target programmed expenditure at 96.3% of Council's original budget.

Notable projects delivered throughout the year include:

- Stage 1 and 2 of New Beith Road upgrade project (total \$16.7 million);
- * Chardon Bridge replacement project (\$3.2 million);
- * City-wide Bus Stop Upgrades (total \$2.5 million);
- * Pindari Street Catchment Master Drainage Project Stages 1 and 2 (\$4.55 million);
- * Dennis Road Catchment Master Drainage Project (\$1.1 million);
- * Tiffany Street Catchment Master Drainage Project Stages 3, 4 and 5 (\$2 million); * Abell Road upgrade project (\$1.6 million);

* City-wide asphalt and spray seal resurfacing program (total \$18 million); and * Contribution towards Johnson Road and Stayplton Road intersection upgrade project (total \$7.6 million).

During the fourth quarter investigations were completed to provide cycle infrastructure on Daisy Hill Road, Daisy Hill (Chatswood Road to Winnetts Road). The project scope to provide a mix of on-road and off-road facilities was adopted and progressed to the design detail stage.

Preparation of a scoping brief for cycle infrastructure along Station Road, Loganlea was also progressed during the fourth quarter. This brief is expected to be completed early in the 2018/19 financial year.

This means a total of three cycle projects were progressed to the detail design stage in the 2017/18 financial year. The combined value of the works is estimated to be nearly three million dollars (\$3M).

The achievement has ensured a three year rolling program of the Cycle Network Infrastructure is maintained.



Interpretation & Response:

Council has experienced a large number of Development Applications in areas where trunk infrastructure has not been provided. In order to service this increased demand, Council is required to enter into infrastructure agreements with developers. The resultant inability to undertake comprehensive planning creates a risk that trunk infrastructure is not provided in a coordinated manner.

Council applied to State Government through the 'Maturing the Infrastructure Pipeline Program (MIPP2) for funds to prepare infrastructure plans for these areas. By the end of the 2017/18 financial year, State had still not informed Council of the funding outcome which would determine the future deliverables for this project. The funding deficit has meant that the project could not commence in 2017/18. Council therefore determined to remove this project from the 2017/18 Operational Plan.

Please note: The status "Undeliverable" means that the project is undeliverable for this financial year (2017/18). This project has been included in the 2018/19 Operational Plan.

The ImagiNation Children's Festival provided a 14-day action-packed program of free or low-cost activities for residents and visitors to the city to enjoy across the 2017 September/October school holidays. 


