Policy title: TREE MANAGEMENT

Directorate: COMMUNITY AND LIFESTYLE

Branch: PARKS

Policy objective: To guide the operational management of trees on

Council managed land which contributes to the environmental quality and amenity of Logan by planning, providing and managing a sustainable,

healthy and safe tree canopy.

Policy scope:

This policy applies to trees managed by Council, including but not limited to trees located on road reserve (made, unmade, urban and rural), cemeteries and within parks. Tree management is undertaken within the relevant acts of legislation and Australian standards which are supported by documents as detailed in the related documents register.

Policy statement:

- 1. Environmental, economic and cultural value
 - (a) Trees are an important and valuable asset to the community that provide a range of benefits. The benefits include environmental quality, habitat, amenity, shade, increased property value and the reduction of carbon in our atmosphere.
 - (b) Tree management will be undertaken according to relevant Federal and State legislation, Australian Standards and local laws including but not limited to those detailed in the related documents register. Council may enter agreements, memorandums of understanding and collaborative relationships with external authorities where benefit is gained for the tree assets of the city.

2. Management of existing trees

- (a) Logan City Council values trees as green assets and healthy trees that do not meet tree removal criteria will be retained in the first instance.
- (b) Parks branch is to be consulted regarding possible impacts to trees as a result of proposed works prior to works commencing. In the event of tree loss or failure, the cost of the cleanup and/or replacement planting and establishment is borne by the party/s undertaking the works.
- (c) Council will maintain a tree register to recognise the value of, encourage the protection of and manage trees of significance and/or of concern. The register for trees of concern is to be maintained detailing trees requiring regular inspections and ongoing maintenance where there is a perception of unacceptable risk such as large trees located in close proximity to private property.
- (d) Requests for tree removal works resulting from the installation of solar panels/billboards/signage will not be supported in the first instance. If the requestor in this scenario is willing to meet the vegetation offset cost then removal will be considered. Determining vegetation offset costs will be calculated using the tree canopy loss calculator. Pruning works will be considered and programmed if appropriate for the specimen tree species and tree condition.

3. Requests for tree works

Requests for pruning and/or removal are to be assessed by a qualified arborist utilising specialised skills and knowledge. A response within specified levels of service will be provided to all stakeholders regarding the outcome of the inspection.

(a) Request for tree works supported by Parks branch

Where there is agreement from Council's Trees Team that the tree should be removed, this work will be programmed and relevant stakeholders will be notified via street tree service notice or email of the removal pending the outcome of a ten working day objection period. A record of the decision will be recorded in Parks official records.

(b) Request for tree works is not supported by Parks branch

Where there is agreement from Council's Trees Team that the tree should not be removed, regular monitoring and ongoing management will be undertaken and relevant stakeholders will be notified of the reasons why removal is not supported. A record of the decision should be recorded in Parks official records.

4. Tree planting

Requests for tree planting are to be investigated to ensure the most appropriate species is chosen when considering the specific location. Planting works will be undertaken in accordance with all relevant legislative requirements.

5. Tree replacement

In the event of a tree removal, a suitable replacement will be undertaken where practical. Replacement may consist of an individual specimen of a reasonable size or where more appropriate, multiple specimens within the vicinity of removal. The city's tree asset will not diminish in volume and Council will progress with increasing its mass and viability.

6. Objections to decisions

If a customer does not accept the reasons why tree removal is or is not supported, and cannot be addressed through education, the most affected property owner/s should be invited to provide a written request outlining the basis of their objection to the Parks Manager who will proceed with the objections process.

7. Community engagement, consultation and education

Council will promote and facilitate the communication and education of the community including schools, developers, contractors, public utilities, non-government organisations and residents in the value and significance of Councils tree assets that contribute to the liveability of Logan.
