New wastewater pipeline, Eagleby to Loganholme

Division 12 Councillor Karen Murphy with the support of the City Infrastructure Chair TeresaLane, is pleased to announce the construction of a new wastewater pipeline and associated infrastructure in Eagleby and Loganholme.

WHAT IS HAPPENING?

Council's Logan Water is starting the first stage of an overall project to transfer wastewater flows from the Beenleigh Wastewater Treatment Plant (WWTP) to the Loganholme WWTP. This project supports our city's growth and will enable the future closure of the Beenleigh WWTP.

Project works involve the installation of 2.4km of new wastewater pipeline and associated infrastructure. This will require vegetation clearing, excavation, laying pipes using open trench and horizontal directional drilling (HDD) methods, and site restoration.

WHEN IS IT HAPPENING?

Some enabling works are underway within the Loganholme WWTP grounds. Vegetation removal along the pipeline routewill begin in November 2021 and the main pipe laying works will start in December 2021. Works are expected to be completed in mid-2022. Construction will generally occur between 6.30am and 5.00pm Monday to Friday. However due the nature of the works, HDD drilling will occur from 6.30am – 5pm for a week or until complete.

Other activities may also be required outside of these times. The timing of works is subject to construction and weather conditions.

WHERE IS IT HAPPENING?

This section of pipeline is from the northern end of River Hills Road at Eagleby to Loganholme WWTP at Chetwynd Street, Loganholme. It passes beneath the Logan River (using a drilling method). Most of the pipeline is in government-ownedland or infrastructure easements. Please refer to the map overleaf.

WHAT CAN I EXPECT?

Logan Water will make every effort to minimise disruption to the community and environment during these works.

Due to the nature of the works, some localised construction impacts are expected including:

- Temporary closure of part of the Logan River Parklands carpark at the public boat ramp. Access to the boat ramp will be maintained at all times.
- Clearing of some vegetation in the work zone in accordance with Council and State Governmentrequirements.
- Increased levels of noise, dust and vibration at times. The site team will implement measures to reduce these impacts as much as practical.
- Frequent truck movements to and from the work site to allow machinery / materials to be delivered and excavated materials removed.



Full restoration of the work zone (such as turfing and concreting) will occur when construction is complete.
