# Heavy Vehicle Parking on Roads Subordinate Local Law No. 7.2

# This fact sheet outlines our local law regulations for heavy vehicle parking on roads in the City of Logan.

Under this local law, a heavy vehicle must not stop on a length of road in a built-up area or in a public place for longer than one hour. Some exceptions apply which include when the driver is

- dropping off or picking up goods for the total time when the vehicle is stopped
- permitted to do so in certain streets / areas or by an official traffic sign.

#### **Definitions**

Heavy Vehicle means a vehicle with a GVM and/or ATM of more than 4.5 tonnes.

**Built-up area** means an area where a vehicle is parked and in which there are buildings on land next to the road, or there is street lighting, at intervals not over 100m for a distance of at least 500m or, if the road is shorter than 500m, for the whole road.

**ATM** (aggregate trailer mass), of a heavy trailer, means the total maximum mass of the trailer, as stated by the manufacturer, together with its load and the mass imposed on the towing vehicle by the trailer when the towing vehicle and trailer are on a horizontal surface.

**GVM** (gross vehicle mass) means the maximum loaded mass of a vehicle shown on the vehicle's compliance plate.

Public place means trust land; a reserve; or Council owned or occupied premises.

**Road means** a local government road and a state-controlled road.

#### Where can I park legally for more than one hour?

Name of road	Suburb	Part of road
Lexington Road	Underwood	Full length – both sides
Kenway Drive	Underwood	Full length – outer side of the loop
Delton Street	Kingston	Full length – both sides
Meakin Road	Kingston	Logan Motorway to Queens Road, Kingston – both sides
Elleslie Road	Meadowbrook	Full length – both sides



Jutland Street	Loganlea	Full Length – both sides
Battle Street	Loganlea	Full length – south side
Central Court	Hillcrest	East / west section – both sides
Elliot Court	Hillcrest	Full Length – both sides
Thorsborne Street	Beenleigh	Full Length – both sides
Centenary Place	Logan Village	Full Length – both sides

#### Maximum penalty for parking for more than one hour is 50 penalty units.

#### Who is exempt?

#### Some exceptions apply which include when the driver is

- Emergency vehicles (ambulance, fire, police)
- dropping off / picking up goods for the total time when the vehicle is stopped
- permitted to do so in certain streets / areas or by an official traffic sign
- workers who have parked vehicles while checking or repairing public utilities such as water, hydraulic power, electricity, gas sewerage, drainage, or telecommunication services
- local government vehicle
- broken-down vehicle
- vehicles involved in road works
- tow trucks loading or connecting to a vehicle
- garbage trucks collecting garbage or recycling
- parked on a road where heavy vehicles are permitted for more than 1 hour.






# Underwood, Woodridge, and Slacks Creek areas






## Loganholme area






### **Crestmead Industrial Estate area**






## **Meadowbrook and Kingston areas**




### **Browns Plains area**






### Hillcrest area
