Request for a Tankering Agreement

However, there may be exceptional circumstances where Council would be prepared to defer the connection to the existing wastewater network that would result in the need for wastewater from the proposed development to collected and conveyed by the developer to a nominated discharge location for short period of time.

1. Site plan

- The site plan should:
- detail the location of the proposed tankering facility;
- detail the location of any existing and proposed buildings;
- detail the location of any existing and proposed residential and commercial properties;
- detail the location of any waterways or environmentally sensitive areas;
- provide the lot and plan numbers; and
- be to scale.

2. Tankering Management Plan

- The Tankering Management Plan (TMP) should include, but is not limited to, the following:
- details of the tankering operations;

- a copy of the contract with the tankering contractor;
- a proposed tankering schedule based on the projected wastewater loads;
- design details and storage capacity calculations for the tankering facility;
- details about the monitoring and warning systems for the tankering facility;
- details about the ongoing reporting of the tankering operations;
- details of the environmental safeguards and odour emission control measures;
- details of the emergency procedures and the emergency contact list;
- details about the security being provided for the tankering facility; and
- details about the decommissioning and removal the tankering facility.
