# Part 1 Preliminary

#### 1 Short title

This subordinate local law may be cited as Subordinate Local Law No. 12.2 (Administration Centres) 2003.

#### 2 Authorising local law

This subordinate local law is made pursuant to Local Law No. 12 (Council Property and Other Public Places) 2003.

#### 3 Object

The object of this subordinate local law is to assist in the implementation of *Local Law No. 12 (Council Property and Other Public Places) 2003* by specifying pursuant to section 9(1) (Regulation of council property) of *Local Law No. 12 (Council Property and Other Public Places) 2003* restrictions on the use of an Administration Centre.

#### 4 Definitions—the dictionary

The dictionary in Schedule 3 (Dictionary) of this subordinate local law defines particular words used in this subordinate local law.

### Part 2 Visitors to an Administration Centre

#### 5 Admission to ticketed performances or events

A person must not enter a public area of an Administration Centre that is open for a ticketed performance or event unless—

- (a) the person is the holder of a ticket, invitation or registration in respect of that performance or event; or
- (b) authorised by the prior written approval of the local government; or
- (c) authorised by a direction of an authorised person.

#### 6 Admission to restricted area

A person must not enter a restricted area unless authorised by—

- (a) the prior written approval of the local government; or
- (b) a direction of an authorised person.

#### 7 Regulated conduct

A person must not—

- (a) use indecent, obscene, insulting or threatening language in an Administration Centre; or
- (b) behave in an offensive, threatening or indecent manner in an Administration Centre; or
- (c) by disorderly conduct cause serious alarm or affront to a person in an Administration Centre; or
- (d) obstruct a council officer in the performance of that council officer's work or duties in an Administration Centre; or
- (e) cause annoyance or inconvenience to any other person in an Administration Centre; or
- (f) stand or loiter to the inconvenience, annoyance or obstruction of any person in an Administration Centre; or
- (g) carry or convey any article or substance of an offensive or indecent character or any article of any length or dimension as to be an inconvenience, obstruction, danger or hazard to any person in an Administration Centre; or
- (h) place or cause or permit to be placed in an Administration Centre anything whatsoever so as to be an inconvenience, obstruction, danger or hazard to any person in an Administration Centre; or
- (i) push into any line of persons in an Administration Centre that has been fixed by an authorised person; or
- (j) obstruct, hinder or prevent the free passage of any person or vehicle in an Administration Centre; or
- (k) do or say anything to hinder or interfere with the proper progress or conduct of an authorised activity in an Administration Centre; or
- (l) contravene any restriction to which the person's entry to an Administration Centre was subject; or
- (m) enter any part of an Administration Centre when excluded or banned by the direction of an authorised person.

#### 8 Recreational activities

A person (other than a council officer acting in the course of the council officer's employment) must not, unless authorised by the prior written approval of the local government or a direction of an authorised person—

- (a) make an address or conduct or hold a meeting, match or musical performance or an amusement or any other event in an Administration Centre; or
- (b) have or operate in an Administration Centre—
  - (i) television, cinematographic or photographic equipment; or
  - (ii) a radio, cassette or other audio equipment or amplifier device; or
  - (iii) an audio or video recorder; or
  - (iv) any audio or visual recording device; or
- (c) consume food or drink in areas where signage indicates that food or drink must not be consumed in an Administration Centre; or
- (d) operate any radio, cassette or other audio player, or play any musical instrument at a volume likely to cause annoyance or inconvenience to any person in an Administration Centre; or
- (e) drive, stand, wheel or park any regulated vehicle in a manner likely to cause annoyance or inconvenience to any person in an Administration Centre; or
- (f) cause or allow any animal (other than a guide dog, hearing dog or assistance dog) to be in an Administration Centre building; or
- (g) bring into or operate in an Administration Centre, a smoke machine.

#### 9 Liquor not to be brought into an Administration Centre

A person (other than a council officer acting in the course of the council officer's employment) must not bring liquor into any public area of an Administration Centre unless authorised by—

- (a) the prior written approval of the local government; or
- (b) a direction of an authorised person.

#### 10 Smoking

A person must not smoke—

- (a) within an enclosed part of an Administration Centre; or
- (b) within 4 metres of an entrance to an Administration Centre building; or
- (c) in an outdoor area where food or beverages are served.

#### 11 Littering

- (1) A person must not deposit or discard any rubbish, litter or waste of any kind in an Administration Centre (other than in a waste container).
- (2) A person must not deposit or discard any rubbish, litter or waste which is generated on premises (other than an Administration Centre) in a waste container situated in an Administration Centre.

#### 12 Interference with signs

A person (other than a council officer acting in the course of the council officer's employment) must not interfere with any sign exhibited in an Administration Centre.

#### 13 Directions

A person must comply with a direction of an authorised person made or given for the purpose of securing the good order, management or enjoyment of an Administration Centre.

#### 14 Distribution of publications

A person (other than a council officer acting in the course of the council officer's employment) must not distribute a publication in an Administration Centre, publicise a publication or engage in a promotional activity in an Administration Centre unless authorised by—

- (a) the prior written approval of the local government; or
- (b) a direction of an authorised person.

#### 15 Interference with an Administration Centre

A person (other than a council officer acting in the course of the council officer's employment) must not, unless authorised by the prior written approval of the local government, interfere with—

- (a) a good in an Administration Centre; or
- (b) any rock, soil, sand, stone, plant or similar substance in an Administration Centre; or
- (c) a council asset in an Administration Centre; or

(d) any part of an Administration Centre.

#### 16 Erection of structures

A person (other than a council officer acting in the course of the council officer's employment) must not erect any building, structure, stall, booth, tent or bar in an Administration Centre, unless authorised by the prior written approval of the local government.

#### Part 3 Vehicles in an Administration Centre

#### 17 Access by vehicles

A person must not, unless authorised by the prior written approval of the local government or a direction of an authorised person, drive, lead, stand, wheel or park a vehicle in an Administration Centre other than in—

- (a) a designated vehicle area; or
- (b) an area which is intended to be used for public access by a vehicle.

#### 18 Compliance with signs

A person must not, unless authorised by the prior written approval of the local government or a direction of an authorised person, cause a vehicle to be driven, lead, stood, wheeled or parked contrary to a sign in an Administration Centre.



# Schedule 3 Dictionary

section 4

Administration Centre means the premises specified in Schedule 1 (Administration Centres) of this subordinate local law.

Administration Centre building means any building located on premises identified in Schedule 1 (Administration Centres) of this subordinate local law.

#### amplifier device means—

- (a) a loud hailer; or
- (b) a megaphone; or
- (c) a public address system; or
- (d) a remote telephone bell; or
- (e) a telephone repeater bell.

assistance dog has the meaning given in the Guide, Hearing and Assistance Dogs Act 2009.

authorised activity means an activity authorised by the local government or an authorised person to occur in an Administration Centre.

council officer has the meaning given in Local Law No. 2 (Administration) 2010.

designated vehicle area means the area which may be used for driving, leading, standing, wheeling or parking a vehicle in an Administration Centre that is specified by a sign.

guide dog has the meaning given in the Guide, Hearing and Assistance Dogs Act 2009.

hazard has the meaning given in Local Law No. 2 (Administration) 2010.

*hearing dog* has the meaning given in the *Guide, Hearing and Assistance Dogs Act* 2009.

*liquor* has the meaning given in the *Liquor Act 1992*.

public area means any part of an Administration Centre that—

- (a) comprises open space; or
- (b) is used for the purpose of a foyer, walkway or other facility of a public nature.

#### restricted area means—

(a) any part of an Administration Centre that is not a public area; and

(b) any part of an Administration Centre (including a public area) that is specified as a restricted area by a sign or an authorised person.

*ticketed performance or event* means a performance or event for which a ticket, invitation or registration must be held for entry to a public area.

waste has the meaning given in the Environmental Protection Act 1994.

waste container means a weatherproof container for the storage of waste that—

- (a) is vermin proof; and
- (b) can be readily cleaned; and
- (c) is constructed of durable material; and
- (d) is non-reactive with the intended contents; and
- (e) is leakproof; and
- (f) minimises the loss of material into the environment.
