NOTE: *Proof of desexing is required to receive the desexed fee. All cats must be desexed unless owned by a registered breeder.
 **Kittens and Puppies: Proof of desexing must be shown upon next registration renewal to continue to receive the desexed fee.

Council will NOT register: American Pit Bull Terriers or Pit Bull Terriers; Japanese Tosas; Dogo Argentino; Fila Brasileiro, Presa Canario or Perro de Presa Canario. Proof of breed identification may be required before registration where any doubt may exist.

DO I HAVE TO REGISTER MY CAT OR DOG?

- YES**
- All cats and dogs over the age of 12 weeks must be registered with Logan City Council.
 - Discount registration fees apply for desexed cats and dogs.
 - Registration should not be confused with microchipping. These are two separate animal identifications.

REGISTRATION TAG

Paying by Mail or BPAY: Your registration tag and receipt will be forwarded by mail upon receipt of payment.

Paying in Person: A receipt and registration tag will be issued at time of payment.

- The registration tag must be fixed to the animal's collar and remain on the animal at all times. If the tag is lost, a replacement is available at a nominal fee.
- IT IS STRONGLY ADVISED that you use a permanent marker to write your phone number on the back of the registration tag.
- The registration period for cats and dogs is 1 July to 30 June. Annual registration fees are payable and an annual renewal notice will be issued in July.
- **A lifetime registration tag will be provided. A replacement tag will only be issued upon request.**

CAT KEEPING IN LOGAN

Under Council's Local Law No. 4 and Subordinate Local Law No.4.1 cats must be:

- desexed unless the cats are owned by a registered breeder.
- kept in an enclosure, building or structure that prevents the cat from escaping from the premises at all times.

LOST AN ANIMAL?

PLEASE:

- Check the Impounded Animals page on our website regularly. A photo and description of each impounded animal is uploaded to www.logan.qld.gov.au
- Visit the Animal Management Centre at least once a day to check for your pet.

There are many reasons why a personal visit to the Animal Management Centre is critical in reuniting you with your pet.

- your cat or dog may have lost its collar or tag
- face to face recognition (many cats or dogs look just like other cats or dogs)
- how our staff describe the breed of your cat or dog and the website listing may be different to how you would recognise your animal
- your animal may be in transit to the Centre
- Check with other Councils in case your pet was impounded outside of Logan City
- Check with animal welfare agencies (contact details below)
