## **Part 1 Preliminary**

### **1 Short title**

This amending local law may be cited as *Amending Subordinate Local Law No. 1 (Subordinate Local Law No. 7.2 (Heavy Vehicle Parking on a Road) 2003) 2023*.

### **2 Object**

The object of this amending local law is to amend *Subordinate Local Law No. 7.2 (Heavy Vehicle Parking on a Road) 2003* to limit heavy vehicle parking in the Springwood locality.

### 3 Commencement
