## **CITY OF LOGAN** Goodna Road Upgrade and **New Beith Road Upgrade** Community Consultation Survey Summary





## Introduction

Logan City Council is assessing options to improve the safety and efficiency of the road network to accommodate the rising traffic demand within Greenbank and surrounding area. The road network being assessed includes Goonda Road and New Beith Road.

The current alignment experiences congestion during the morning and afternoon peaks. To address this congestion, the proposed solution will aim at providing the following benefits to the community:

- improved safety as traffic increases
- less congestion and more reliable travel times as traffic increases
- reduce the impacts of flooding on the road network
- improved connectivity to Springfield and beyond
- better and safer walking and cycling opportunities.

Feedback on the alternate alignments for the long-term solution (Goodna Road Upgrade and New Beith Road Upgrade) was sought from the community via a 'Have Your Say' survey open from 25 March 2022 through to 29 May 2022.

This report is a summary of the community feedback provided to Logan City Council. We would like to thank all those who took the time to take part in the survey and those who attended the community event.

# **Project details**

Goodna Road and New Beith Road are expected to see considerable traffic growth in the future years linked to rising demand in the surrounding areas.

Options for upgrade being considered include:

- upgrading the current road alignment on the relevant sections of Goodna Road and New Beith Road
- a new alignment bypassing Greenbank State School (directly linking New Beith Road with both Middle Road and Ison Road).

The chosen solution may incorporate portions of each option to improve connectivity, traffic flow and travel times.

# Have Your Say

The **'Have Your Say'** survey was open between 25 March 2022 through to 29 May 2022.

An in-person community information event was held on Saturday 14 May 2022. During the in-person event the project team was able to talk through the proposed plans and hear feedback from attendees.

The online survey was distributed by several sources including:

- Logan City Council Letter
- Social Media
- Electronic signs along the road
- Local Councillor (meeting/social media)

The largest group of respondents heard of the survey from the Logan City Council Letter distributed. Respondents were asked:

- How did you hear about this survey?
- How often do you travel along Goodna Road and/or New Beith Road?
- In considering an alignment and design for roads in the study area, please rank the nominated criteria in terms of their importance (1 being the highest priority)
- Do you have any additional feedback you would like to provide?

# Survey Participation


Respondents were asked to rank the following from most important to least important:

- Improving traffic performance and integration (reducing congestion and improving network travel times).






Survey responses were received from residents across various suburbs. The majority of respondents live in the suburbs of Greenbank and New Beith.


# What You Told Us


