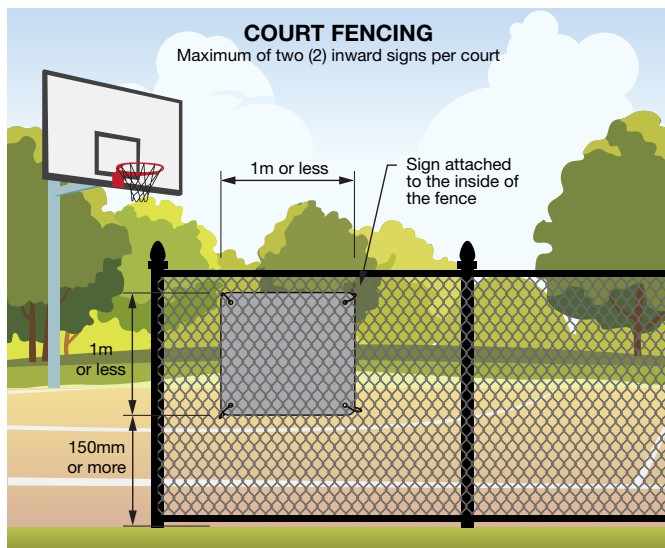




# SPONSORSHIP SIGNAGE

## ON COUNCIL OWNED OR CONTROLLED LAND LEASED TO SPORT, RECREATION AND COMMUNITY ORGANISATIONS

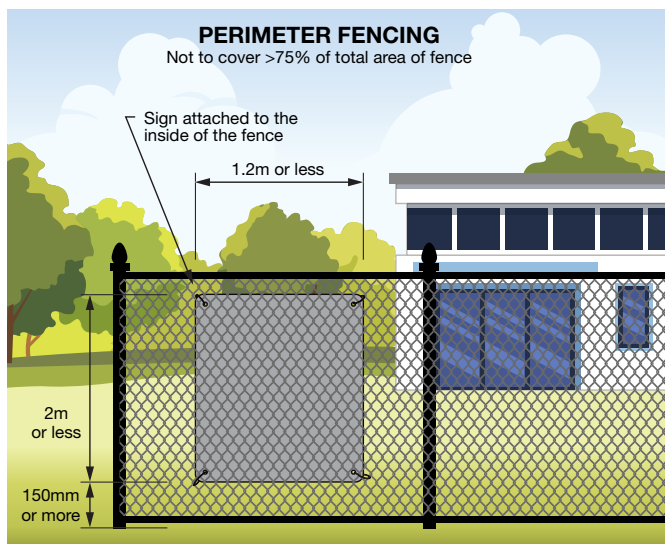
To ensure the consistent management of sponsorship signage on Council owned or controlled land the following guidelines have been developed for sport, recreation and community organisations, to use as a reference when selecting the size, position and content of any future sponsorship signs.



Sign materials to be durable & weatherproof



Signs must not be offensive, discriminatory or political in nature



How do I apply for approval?	Any sport, recreation or community organisation wishing to erect sponsorship signage should apply to Council for landowner's consent. Please note this process may take up to 8 weeks.
Size	Signs must be no higher than 2m and no wider than 1.2m in size.  Signs must be fixed to field fencing and must not extend above or below the fence.  There must be a gap of 150mm from the base of the sign for ease of maintenance and to allow for flow of water.
Location	Signs must be located so as to be visible only to persons inside the complex and should not be visible from surrounding roads, streets or residential areas.  Signs must be attached to the inside of the fence surrounding the field/perimeter of the facility.  Signs must not be painted directly on to walls or roofs of any facility, building or structure.
Material	Sign panels must be constructed of a suitable material (colourbond, alupanel, corflute) with computer cut and digital print graphics.
Method of attachment	Signs should not be attached to any other fixtures or structures within a sport, recreation or community facility including; amenity buildings, storage sheds, trees, public toilets, retaining walls, seating and bollards.
Content	Political signage is not acceptable. An exception is if the local member is a patron of or sponsors the club - signage to that effect is acceptable.  Signs must be appropriate for a community facility and not in any way offensive or discriminate on grounds of race, gender or religion.
Visual amenity	Signs on court fencing is limited to two (2) inward signs per court being no greater than 1 metre x 1 metre per sign.  Signs placed on field/perimeter fencing must not cover more than 75% of the surface area of the entire fence.
Maintenance	In accordance with current lease conditions, clubs are expected to maintain all sponsorship signage in an acceptable and safe condition at all times including the immediate removal of graffiti, damaged and broken signs.
Term	Signs to be removed at the expiration of the sponsorship agreement or expiry of the lease.
