Yellow Lines and Residential Parking

Council is here to help residents when parked vehicles block access to local streets and traffic flow. Many residents request yellow "no stopping" lines but did you know we often resolve these issues through our Community Parking enforcement?

Yellow Lines - Did You Know?

Yellow "no stopping" lines mean you can't park or stop your car at that location. Queensland Road Rules say it is illegal to park or stop on a yellow line. Our Community Parking team enforce this rule.

Council doesn't always install yellow lines however here are some scenarios where we might. We will consider placing a yellow line in these locations:

- · intersections with traffic lights
- intersections without traffic lights with high traffic flow
- areas where sharp bends or crests make it unsafe to park
- where parked cars cause traffic congestion.

We will not generally place yellow lines:


- · across or opposite domestic driveways, or
- on slow quiet streets with low traffic volumes.


Driveways

We don't paint yellow lines across driveways. Queensland Road Rules say that it is illegal to park across a driveway. These issues are resolved by enforcement.




Intersections

The Queensland Road Rules say it is illegal to park within 10 metres of an intersection without traffic lights and within 20 metres of an intersection with traffic lights. You can report vehicles parked in these areas to us for enforcement. Should the problem continue, we may consider installing yellow lines.



Did you know it is legal to park along the outer side of the continuous road at a T-intersection?







Narrow Streets and the 3 Metre Rule

A road is deemed 'narrow' if the drivable surface, excluding kerbs and gutters, is less than 6 metres wide. A width of 6 metres allows for a vehicle to park on the road and for another vehicle including emergency and service vehicles to safely pass. Queensland Road Rules say there must be a minimum distance of at least 3 metres between parked vehicles and unbroken center lines, medians and other parked vehicles. Parking closer than 3 metres can block access for motorists and emergency vehicles. You can report this to Council for enforcement.






Missed Bins

If your bin wasn't collected because a parked car blocked access for the waste collection, please consider leaving your bins within your driveway.

If your bin isn't emptied after 24 hours, you can lodge a missed bin collection request on our website: logan.qld.gov.au/missed-waste-collection or call us on (07) 3412 3412.

We don't install yellow lines for missed bins unless waste collectors are unable to access or turn around in your street.
