

2026/27 Application for Extra Bulk Bins – Body Corporate

This form can be used by body corporate representatives to apply for extra bulk bins – that is – above the standard service that is required for the number of units in the complex. For example, for use in common areas or to manage excess waste. Charges will be levied to the community titles scheme and not strata-titled unit owners.

Bulk waste bins are emptied one day a week, but they can be emptied up to 3 days a week for an extra charge.

The yearly charge applies for each collection day in the same week. For example, a 1,100 litre waste bin emptied 2 days a week is \$2,788 a year.

Bulk recycling bins are emptied one day a week only. Extra service days aren't available.

By submitting this request for an additional bin, you acknowledge the following:

- Once council is satisfied that the bins have been delivered to the property, charges will be added on the rates account for the property.
- Charges will cease upon the service being cancelled by the property owner and Council has collected the bins.
- Council will charge your rate account for the service irrespective of whether you place your bin out for collection or not. Refunds for periodic non-use of the service are not permitted.
- Should collection be missed due to operational issues, refunds will not be provided, however Council will make best endeavours to offer a catch-up service upon request.
- By agreeing to these conditions of service, you agree to only use the bin for its intended purpose as advertised by Logan City Council. Failure to do this could result in the removal of the bin without refund.
